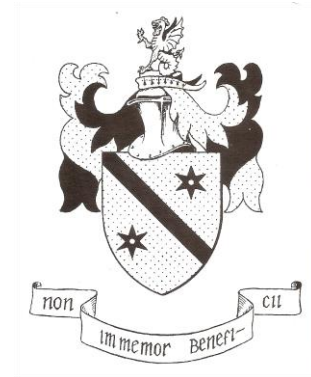

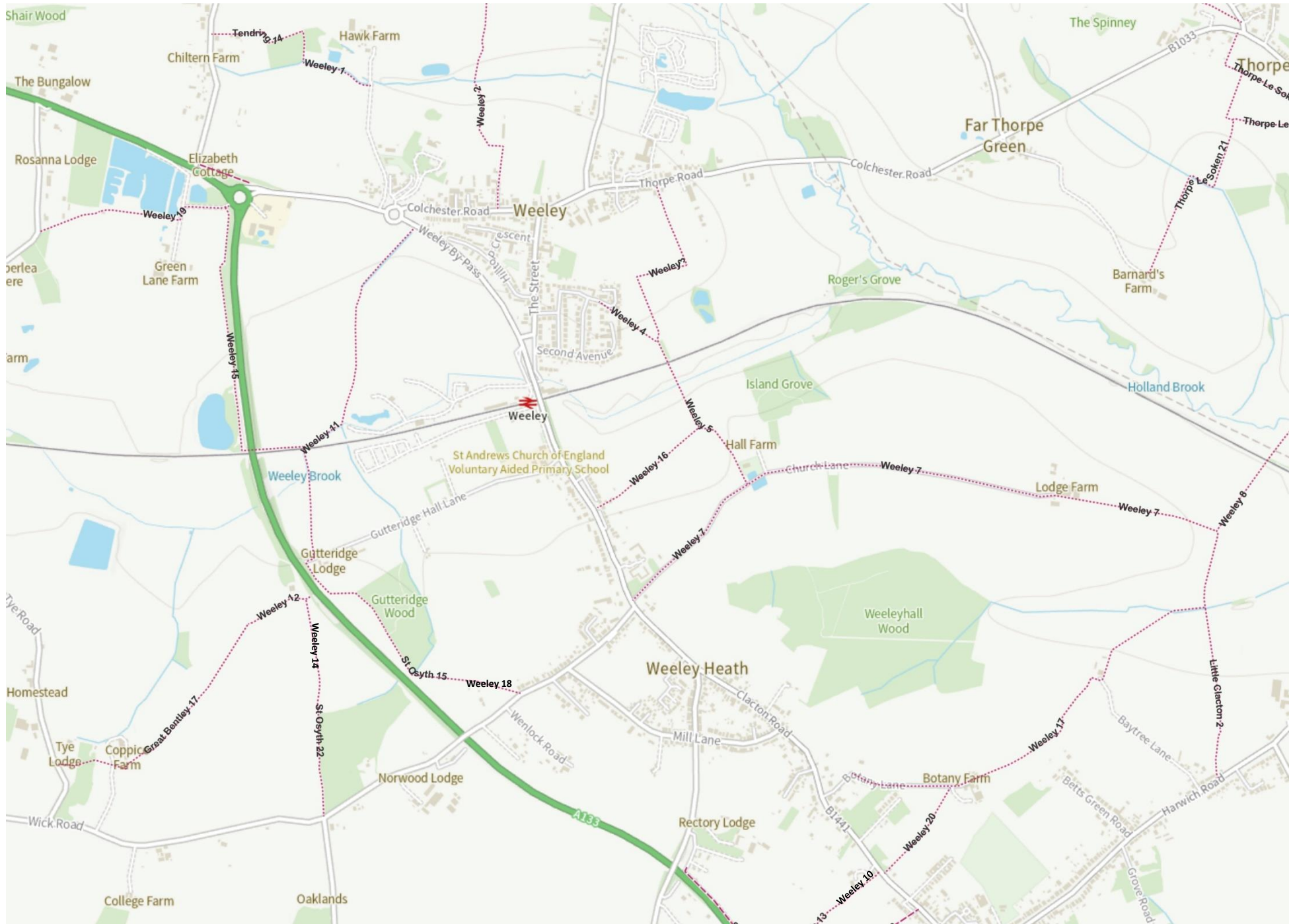
Public Rights of Way Weeley and Weeley Heath Footpaths

Essex County Council is responsible for the Definitive Map which was produced in 2002 and shows all Public Rights of Way in Essex.

Weeley Parish Council has a copy of the Definitive Map covering Weeley and Weeley Heath.

The code for each Footpath is the Number plus the Parish Code of 182.
For example: FP1 182 is the number of Footpath 1 in the parish of Weeley.

Below is a map showing where each footpath is located together with a list providing additional information relating to the length, number and where they are situated.



Footpath Number	Description of Footpath
1	From the road south of Hawk Farm in a westerly then northerly direction to the parish boundary with Tendring where it continues as Footpath 14. Minimum width of path from the road south of Hawk Farm to the footbridge is 2 metres. The length of the footpath is approximately 367 metres.
2	From the road east of Mount Pleasant in a northerly direction along the parish boundary with Tendring where it continues as Footpath 10. The length of the footpath is approximately 814 metres.
3	From the road west of Brook Farm in a south easterly and westerly then southerly direction to its junction with Footpath 4. The length of the footpath is approximately 711 metres.
4	From St Andrews Road south easterly to its junction with Footpaths 3 and 5. The length of the footpath is approximately 248 metres.
5	From its junction with footpaths 3 and 4 in a south easterly direction over the railway to its junction with Footpath 7. The length of the footpath is approximately 608 metres.
7	From the road west of Pond Farm in a north easterly and easterly direction south of Weeley Lodge to its junction with Footpath 8. The length of the footpath is approximately 2,239 metres.
8	Continuation of Footpath 2 from Little Clacton in a north easterly direction crossing the railway to the parish boundary with Thorpe-le-Soken where it continues as footpath 11. The length of the footpath is approximately 737 metres.
10	From Little Clacton south east of Gate Farm in a south westerly direction to the parish boundary with St Osyth where it continues as Footpath 13. The length of the footpath is approximately 169 metres.
11	From Colchester Road west of Brickhouse Farm leading southwards and the south-westwards to meet Footpath 15 and to cross the railway east of the A133. Then southwards to Gutteridge Hall and westwards to the A133. Then south eastwards along the highway boundary for 145 metres. Then eastwards to the western corner of Gutteridge Wood and south-eastwards to the parish boundary where it continues as Footpath 15 in St Osyth. The length of the footpath is approximately 1,734 metres.

12	From the A133 leading westwards across the northern end of Footpath 14 and continuing south westwards to the parish boundary where it continues as Footpath 17 in Great Bentley. The length of the footpath is approximately 244 metres.
14	From its junction with footpath 12 in a southerly direction to the parish boundary with St Osyth where it continues as Footpath 22. The length of the footpath is approximately 156 metres.
15	From the A133 Colchester Road opposite Crown Lane leading southwards to Green Lane Farm then south-eastwards to the A133 Little Clacton and Weeley Heath Bypass. Then southwards within the highway boundary to the railway. Then eastwards under road and along northern side of railway to meet Footpath 11. The length of the footpath is approximately 1,080 metres.
16	From the road southeast of school in a north easterly direction to its junction with Footpath 5. The length of the footpath is approximately 451 metres.
17	From the road north of Gate Farm in an easterly and north easterly direction to its junction with Footpath 8, at the parish boundary. The length of the footpath is approximately 1,519 metres.
18	Continuation of St Osyth Footpath 15 in a south easterly direction to the road south west of Folly Farm. The length of the footpath is approximately 152 metres.
19	From the A133 leading south-westwards to continue as Footpath 15 in Tendring. The length of the footpath is approximately 490 metres.
20	From Botany Lane to Weeley Road. The length of the footpath is approximately 378 metres.

There is no footpath number 6, 9 and 13.

NOTE: Pavements which run alongside main roads are known as ‘Pavements’ or ‘Footways’ and not Footpaths.
